NJAA TEAM SALES COMPETITION

The National Junior Angus Association and the Events and Junior Activities Department of the American Angus Association will co-sponsor a team sales competition during the National Junior Angus Show (NJAS). The objective of the contest is to gain a working understanding of performance and pedigree information. Emphasis will be placed on **team organization**, **communication skills** and **sales techniques**.

Winners will be selected in three age divisions. Each winning team will receive an award for each team member. Awards will be given to the top three teams in each division (1st, 2nd and 3rd place).

NJAA TEAM SALES COMPETITION GUIDELINES

- 1. Each state association may enter one team in each age category. This contest is available to the following age divisions, as of Jan. 1 of the current year: Junior (8-13), Intermediate (14-17) and Senior (18-20). Mixed teams may enter but their division will be determined by the age of the oldest member of the team. Each team will consist of three or four individuals. Participants must be junior, regular, or life members of the American Angus Association.
- 2. In the occurrence of a state not having three members present for a team, they may ask a junior member from another state to compete on their team. Combined teams must consist of at least two members from the same state. However, if a state association has a team, no one else from that junior association may compete on a combined state association team. Sweepstakes points will not be counted for combined state teams.
- 3. **Teams must sign up prior to or during the registration period**. The order of team presentation will be determined by a drawing after pre-registration.
- 4. The senior division will be provided with a complete scenario on the day of the registration. The team is required to select their own animal and to find a pedigree to match the scenario. It is not necessary that the animal and the pedigree correspond. See scenario example at end of rules.
- 5. Presentations need to be a minimum of 5 minutes long, with a maximum of 8 minutes. The presentation will not be stopped but points will be deducted at ½ point per judge for each 10 seconds over the 8 minutes allowed. Following the conclusion of the presentation the team will be allowed up to 3 minutes to answer questions from the judges. Judges will not interrupt the presentation to ask questions. All questions will be asked at the conclusion of the presentation. A one minute warning will be given by the event official.
- 6. Each individual on the team will be expected to speak during the presentation. The objective of each team is to sell their heifer, bull or cow-calf pair to the judges. The following three topics should be discussed: (a) pedigree information, (b) performance information (c) visual characteristics. Other information may be included in the sales pitch. The judge's questions will not necessarily be limited to the three topics listed above. Teams will be discounted for using notes.
- 7. Each team will be responsible for selecting a heifer, bull or cow-calf pair to use in the competition. Bulls, heifers and cow-calf pairs are not to be groomed; but, should be clean. Animals will be checked before entering the competition area. No show halters and no grooming supplies will be allowed in the competition area.
- 8. Each team is allowed to enter the ring with only three copies of the registration paper and the animal being marketed. A printed out electronic version of the paper is acceptable.

Points will be deducted for teams not supplying three copies of the registration certificate. The certificate may or may not belong to the exact animal being presented. No additional outside information is allowed.

9. Points will be awarded as follows:

Content – 10 points Ability to communicate – 10 points Team organization – 10 points Overall effect – 10 points Knowledge & Response to Questions – 10 points

Any presentation that is less than 5 minutes will be deducted 2 points per judge per minute. Presentations will be deducted ½ point per judge for each 10 seconds over the 8-minute time limit.

Point Deductions:

Registration certificate missing
Failure to follow contest guidelines

10. Judging will be by a three-member panel of judges based on 50 points maximum from each judge. The contest official will inform the judges if any points need to be deducted for time violations. Each judge shall total their score and rank the contestants in numerical order on the basis of their score. (Highest score first, lowest score last.)

The rankings (not the score) of the three judges shall be added for each team, and the final placings determined by the lowest composite rankings. Actual scores will be used only to break ties. In the event the participants are still tied, they shall be named co-winners and two awards will be given for that placing and none given for the following placing.

11. Judges will act as the buyer of the animal, proposing questions regarding the animal, sales package and other techniques presented by the team.

Scenario Example:

A producer starting a new cow/calf operation in the Southwest has come to you looking for a group of five females to use as a foundation of the producer's new Angus herd. Their progeny will be marketed to feedlots and kept as replacements. Soundness plays an important role in selection decisions due to the rugged terrain and scale of grazing. Cattle need to be able to thrive on limited resources of the region and handle a low-input operation. Help this producer find a group of females that would best fit the new operation.
